#### **DGAT** statement

## <u>Aims</u>

Coaley C of E Primary Academy aims to include all pupils, including those with disabilities, in the full life of the school. Our strategies to do this will include:

having high expectations of all pupils

- finding ways in which all pupils can take part in the full curriculum including sport, music and drama
- planning out-of-school activities including all school trips and excursions so that pupils with disabilities can participate
- setting admissions policy and criteria which does not discriminate against pupils with disabilities or treat them unfairly
- devising teaching strategies which will remove barriers to learning and participation for pupils with disabilities
- planning the physical environment of the school to cater for the needs of pupils with disabilities
- raising awareness of disability amongst school staff through a programme of training when available and if appropriate
- by providing written information for pupils with disabilities in a form which is user friendly
- by using language which does not offend in all its literature and make staff and pupils aware of the importance of language.
- By having a risk assessment in place for pupils with disabilities
